**VERDICT**

1. **COUNT TWO**

**18 U.S.C. § 1001 & Fla. Statutes §§837.05, 837.011  
(Fraud on the American People and the Federal and Florida Governments)**

Pertaining to 18 U.S.C. § 1001 the Citizens' Court finds the following:



3. The Citizens' Court finds that Defendant Obama made a false statements, orally and in writing, to the American people regarding his status as a national born citizen eligible for the Office of President and that Defendant Obama concealed material facts regarding his citizenship and eligibility to be President.
4. The Citizens' Court further finds that Defendant Obama made the false statements regarding his citizenship and eligibility to be President and/or concealed material facts regarding his citizenship and eligibility to be president, willfully, knowingly, and/or with reckless disregard of the truthfulness of the statements.
5. The Citizens' Court also finds that the American people relied on Defendant Obama's false representations that he is a natural born citizen and eligible to be President and in reliance on said misrepresentations, the American people voted for him, having now twice elected him as President of the United States in 2008 and 2012.
6. The Citizens' Court finds that because of the willful false representations made by Defendant Obama, the American people have been defrauded into electing an illegal person for the Office of President of the United States.

Pertaining to Fla. Statutes §§837.05, 837. 011 the Citizens' Court finds the following:

7. The Citizens' Court finds that Defendant Obama gave false information, orally and in writing, to law enforcement officers regarding his status as a national born citizen eligible for the office of President.
8. The Citizens' Court further finds that Defendant Obama knowingly gave false information to law enforcement officers regarding his citizenship and eligibility to be President.
9. The Citizens' Court finds that because of the false information knowingly given to a law enforcement officer by Defendant Obama regarding his citizenship and eligibility to be President, Defendant Obama has defrauded the law enforcement officers and the American people into electing an illegal person for the Office of President of the United States.

The Citizens' Court Orders as follows:

Count Two of the Crimnal Indictment, Fraud on the American People pursuant to 18 U.S.C. § 1001 the Citizens' Court's verdict is:

SENTENCING

Defendant having refused to appear and thus being a fugitive are hereby sentenced to:


Five (5) years of imprisonment for the violations of 18 U.S.C. § 1001; and

Five (5) years of imprisonment for the violations of Fla. Statutes §§837.05, 837. 011;

for a total of Ten (10) years of imprisonment.

The Defendant shall forthwith surrender himself into the custody of the American people and the people of Florida.
