SUPPLEMENT TO JOINT STATUS REPORT

Plaintiff Freedom Watch here supplements its portion of the Joint Status Report of June 29, 2015. On August 19, 2015, the Obama Justice Department responded to its "search" using only three search terms that were ordered by the Court. Predictably, they "found" no documents.

The State Department shall file a status report, no later than Monday, September 21, 2015 at 12:00 p.m., informing the Court of the following: (1) the process agreed upon between the FBI and the State Department for the sharing of information relevant to this lawsuit; (2) the status of the Inspector General of the State Department's report regarding Mrs. Clinton's use of a private server; and (3) a timetable for the completion of any ongoing searches related to this lawsuit.
