RE: Indictment of State Attorney Angela Corey by Florida Citizens' Grand Jury – Request for State Prosecution.

### Dear Governor Scott:

As you may know, I am the Citizens' Prosecutor of Citizens' Grand Jury located in Ocala, Florida. I am also the founder of Judicial Watch and Freedom Watch and am a Florida lawyer.

On Tuesday, June 25, 2013, the Citizens' Grand Jury voted a true bill of indictment with regard to the criminal conduct of State's Attorney Angela Corey. I am enclosing a copy of this indictment, as well as a press release that was issued after it was handed down. Together, they set forth the basis of the charges and underscore the need for your office to take immediate steps to arraign and prosecute Ms. Corey under Florida law – particularly given the additional incriminating facts which have emerged during the on-going George Zimmerman trial. These facts show unequivocally that she withheld exculpatory evidence in the criminal arrest warrant and complaint which she swore against under oath, thus instituting a precipitous - and now it appears to any rational person - a frivolous criminal proceeding against Mr. Zimmerman.

The prosecution of State's Attorney Angela Corey is necessary on an expeditious basis to not only mete out justice, but under these regrettable circumstances, to preserve the integrity of

Florida law enforcement. Prosecutors, no more than ordinary citizens, are not above the law. Indeed, their integrity must be far from reproach as they wield enormous power and their improper actions can ruin lives, even if the person charged is ultimately acquitted. State's Attorney Angela Corey has abused this power and grossly disserved not only George Zimmerman, but the state and people of Florida. She must be held accountable by Florida law enforcement authorities and indeed it is your duty, as the highest government official in the state, to insure that justice is done through the appropriate authorities.

I would like to meet with you at your earliest convenience to discuss and facilitate moving this matter forward through the Florida justice system. In this regard, I will have my Chief of Staff contact your scheduler tomorrow, July 9, 2013.

## **CRIMINAL INDICTMENT**

### THE GRAND JURY CHARGES THAT

#### **GENERAL ALLEGATIONS**

- 1. Defendant ANGELA COREY, (hereinafter referred to as "Defendant COREY"), the head prosecutor for the George Zimmerman murder trial, serves as the State Attorney in Florida's Fourth Judicial Circuit Court. She was elected in 2008.
- 2. 5 U.S.C. § 3331 reads as follows: "I, \_\_\_\_\_\_, do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; that I take this obligation freely, without any mental reservation or purpose of evasion; and that I will well and faithfully discharge the duties of the office on which I am about to enter. So help me God."
- 3. The Fifth Amendment to the U.S. Constitution states in pertinent part, "[n]o person shall be . . . deprived of life, liberty, or property, without due process of law . . ."
- 4. Section I of the Fourteenth Amendment to the U.S. Constitution states in pertinent part, "[n]or shall any State deprive any person of life, liberty, or property, without due process of law..."
- 5. Article III of the Florida Constitution reads as follows: "I do solemnly swear (or affirm) that I will support, protect, and defend the Constitution and Government of the United States and of the State of Florida; and that I am duly qualified to hold office under the Constitution of the State, and that I will well and faithfully perform the duties of on which I am not about to enter, so help me God."
- 6. Florida Statute § 837.05 states, "...whoever knowingly gives false information to any enforcement officer concerning the alleged commission of any crime, commits a misdemeanor of the first degree ..."



- 7. Florida Statute § 843.0855 states, "Any person who simulates legal process, including, but not limited to, actions affecting title to real estate or personal property, indictments, subpoenas, warrants, injunctions, liens, orders, judgments, or any legal documents or proceedings, knowing or having reason to know the contents of any such documents or proceedings or the basis for any action to be fraudulent, commits a felony of the third degree . . ."
- 8. Defendant COREY violated the oath of office as set forth in the United States Code and Florida's Constitution by deliberately and willfully withholding information from the court by submitting an incomplete affidavit.
- 9. Defendant COREY was aware when she submitted an affidavit that it did not contain the truth, the whole truth, and nothing but the truth. She deliberately withheld evidence that supported George Zimmerman's claim of self-defense.
- 10. It had been reported and became widely known that the police had "a full face picture" of Zimmerman, before paramedics treated him, that showed a "bloodied nose."
- 11. Defendant COREY also had photographic evidence of bruises to the back of his head.

# **COUNT ONE**

(5 U.S.C. § 3331 and Art. II § 5(b) Fla. Const.) (Violation of the Oath of Office)

# THE GRAND JURY FURTHER CHARGES:

- 12. Paragraphs 1 through \$\mathbf{g}\$ of the General Allegations are realleged here.
- 13. Defendant COREY failed to support and defend the Constitution of the United States and the Constitution of Florida when she submitted an arrest affidavit for George Zimmerman that did not contain the whole truth and nothing but the truth.
- 14. In doing so, Defendant COREY denied George Zimmerman, a person consistent with the definition set forth in the Fifth Amendment to the U.S. Constitution, due process of law and therefore violated her oath of office to uphold the Constitution of the United States and the Constitution of Florida.
- 15. In addition, Defendant COREY, acting as State Attorney, violated the Fourteenth Amendment of the U.S. Constitution when she, with color of state authority within the definition of the Fourteenth Amendment, deprived George Zimmerman due process of law.
- 16. Because of her knowing and willful violations of the Fifth and Fourteenth Amendments to the U.S. Constitution, Defendant COREY violated her oath of office to uphold and protect the U.S. Constitution and Florida Constitution.

17. Defendant COREY knowingly and willfully falsified, concealed, and covered up a material fact necessary to provide the whole truth and nothing but the truth.

**COUNT TWO** 

(Fla. Statutes §§ 837.05, 843.0855)

# (Criminal Actions Under Color of Law or Through Use of Simulated Legal Process, False Statements)

# THE GRAND JURY FURTHER CHARGES:

18. Paragraphs 1 through / of the General Allegations are realleged here.

- 19. Defendant COREY violates Florida Statutes when she knowingly gave false and incomplete information to the court when she failed to mention the injuries sustained by George Zimmerman that supports his self-defense claim.
- 20. Defendant COREY knowingly and willingly obstructed or impeded the proper administration of the law by deliberately withholding evidence that showed George Zimmerman with a "bloodied nose."
- 21. Defendant COREY had photographic evidence of bruises to the back of George Zimmerman's head.
- 22. Defendant COREY knew that the contents of her arrest affidavit did not contain the truth, the whole truth, and nothing but the truth.
- 23. Defendant COREY intentionally and deliberately submitted an incomplete affidavit that withheld evidence potentially exonerating George Zimmerman. She knew the contents of the legal documents she produced, the affidavit were fraudulent.

24. Because of these acts, Defendant COREY violates Florida Statutes by acting under color of law and abusing the legal process.

# ZIMMERMAN PROSECUTOR ANGELA COREY CRIMINALLY INDICTED BY CITIZENS' GRAND JURY FOR ALLEGEDLY FALSIFYING ARREST WARRANT AND COMPLAINT



(Ocala, Florida, July 2, 2013). Florida State's Attorney Angela Corey has been indicted by a citizens' grand jury, convening in Ocala, Florida, over the falsification of the arrest warrant and complaint that led to George Zimmerman being charged with the second degree murder of African-American teenager Trayvon Martin in Sanford, Florida.

The indictment of Corey, which was handed down last week (see www.citizensgrandjury.com), charges Corey with intentionally withholding photographic evidence of the injuries to George Zimmerman's head in the warrant she allegedly rushed to issue under oath, in an effort to boost her reelection prospects. At the outset of this case, black activists such as Jesse Jackson and Al Sharpton, who whipped up wrath against Zimmerman, demanded that he be charged with murder, after local police had thus far declined to arrest him pending investigation.

Following Corey's criminal complaint charging Zimmerman, legal experts such as Harvard Law Professor Alan Dershowitz condemned her for falsely signing an arrest affidavit under oath, which intentionally omitted exculpatory evidence consisting of the photographs showing the injuries Zimmerman sustained, and rushing to charge him with second degree murder under political pressure. Dershowitz called her actions unethical and themselves crimes (http://www.nydailynews.com/opinion/drop-george-zimmerman-murder-chargearticle-1.1080161).

Larry Klayman, a former U.S. Justice Department prosecutor, a Florida lawyer since 1977, and now the "citizens' prosecutor" presided over the Ocala grand jury and said this: "The Supreme Court has confirmed that the grand jury belongs to the American people, not the three branches of government. (504 U.S. 36, 48 (1992) (quoting United States v. R. Enterprises, Inc., 498 U.S. 292, 297 (1991)). By indicting Florida State Attorney Angela Corey, the people are exercising their God given rights, recognized by our Founding Fathers, to mete out justice when the political and legal establishment subverts the rule of law. Hopefully, this indictment will serve as a warning to the political and legal establishment that they are not above the law. Ironically, Corey will now be tried and likely convicted for her alleged crimes - which resulted in Zimmerman being charged under false pretenses, now coming home to roost during Zimmerman's on-going trial. Corruption cannot be tolerated, particularly by law enforcement officers who are elected by the people to serve their ends, not the law enforcement officer's political ends."
