Re: Updated Complaint concerning Massive Damage Caused By Defendants as a Result of Covid-19 Release From an Illegal and Internationally Outlawed Bioweapons Facility in The City of Wuhan of The People's Republic of China

To: Office of The Prosecutor International Criminal Court The Hague, Netherlands

On behalf of Freedom Watch, Inc, the people of the United States and foreign nations please file and process this Updated Complaint against the People's Republic of China, its President, the Chinese Politburo and others who are alleged to have committed crimes against humanity with regard to the death and destruction caused by the criminal creation and release of the COVID-19 variation of coronavirus.

This Updated Complaint includes new material in sections

¶¶ 38-41 Relating to the analysis of Dr. Harvey Fineberg, Chairman of the National Academy of Science's Standing Committee on Emerging Infectious Diseases and 21st Century Health Threats, warning that "research shows that aerosolized droplets produced by talking or possibly even by just breathing can also spread the virus."

¶¶ 42-43 Relating to studies from scientists at Princeton University undergoing peer review show that COVID-19 can survive in the air for up to three hours and be transmitted in the air and can survive on inanimate surfaces for up to three days.

¶¶ 44-49 Relating to how now the United Kingdom's "Ministers fear that the coronavirus pandemic might have been caused by a leak from a Chinese laboratory..."

¶¶ 58-66 Relating to news reports that two years ago U.S. Customs and Border Protection agents at Detroit Metro Airport stopped a Chinese biologist with three vials labeled "Antibodies" in his luggage and "Inspection of the writing on the vials and the stated recipient led inspection personnel to believe the materials contained within the vials may be viable Middle East Respiratory Syndrome (MERS) and Severe Acute Respiratory Syndrome (SARS) materials," says an unclassified FBI tactical intelligence report

 \P 67 Relating to the reopening of the Wuhan seafood market showing it was not the source.

¶ 68 Reports that China is testing nuclear weapons in violation of treaties.

¶¶ 71-72 Discussing how even now, China's government is still repressing the flow of information about the COVID-19 version of coronavirus, and limiting any information about COVID-19 even now.

¶¶ 73-78 Relating to a documentary by a video production of <u>The Epoch Times</u>, "Coronavirus – The Lies and the Truth," by Joshua Phillips, China's deceptions, suppression of the truth about the spreading disease, and failures recklessly spread the disease so widely that a global pandemic became inevitable from these early failures.

¶ 95 A report from the <u>Times of Israel</u> that if interventions in China had been conducted three weeks earlier, transmission of COVID-19 could have been reduced by 95 percent.

¶ 96 Relating to cables from two years ago within and through the U.S. State Department warned that the Wuhan Institute of Virology posed a danger of a viral outbreak into Hubei Province from the materials being handled at the laboratory:

 \P 97 Relating to news that the virus is mutating, suggesting its high danger and design as a likely biological weapon.

Please proceed with urgency given the gravity and effects of the alleged crimes against humanity. It is now becoming widely acknowledged that China's suppression of information that it was required by treaty to share about the developing epidemic and its likely origins from a laboratory in China directly caused the worsening of this pandemic.
