Re: Supplemental Information for our previously-filed Complaint concerning Massive Damage Caused By Defendants as a Result of Covid-19 Release From an Illegal and Internationally Outlawed Bioweapons Facility in The City of Wuhan of The People's Republic of China

On behalf of Freedom Watch, Inc, the people of the United States and foreign nations we ask you to please receive the following additional information as a supplement to our Updated Complaint previously filed against the People's Republic of China, its President, the Chinese Politburo and others who are alleged to have committed crimes against humanity with regard to the death and destruction caused by the criminal creation and release of the COVID-19 variation of coronavirus.

News reports out of Australia – near to China and closely affected by the COVID-19 pandemic – have revealed new information that we believe the ICC should have available to it. Australia's <u>Saturday Telegraph</u> newspaper (affiliated with the Australia <u>Daily Telegraph</u>) reported on May 2, 2020, that a confidential 15 page report or "dossier" about the current coronavirus global pandemic contains a very extensive array of important revelations about China's actions, inactions, and cover-ups of COVID-19.

Australia's <u>Saturday Telegraph</u> reports that it "exclusively" obtained the 15 page report from the "Five Eyes" consortium of intelligence agencies which often work together from the United States, Canada the United Kingdom, Australia, and New Zealand. (The Five Eyes constitute cooperation among these companies and not a separate organization.)

The complainants here believe that the ICC should have access to the full report in considering the impact of the COVID-19 variation of a coronavirus upon the world's population and economy, and China's secrecy, destruction of samples, and withholding of vital information including samples for the development of a vaccine in violation of

China's international treaty obligations including the World Health Organization and World Trade Organization treatese and recklessness causing crimes against humanity.

Australia's <u>Saturday Telegraph</u> extensively reported the actual contents of the report, and printed in the form of the newspaper's analysis perhaps one-third of the entire actual 15 page report. The news report from Australia has been widely repeated throughout the world.

However, the actual report itself has not been revealed anywhere that we can find. Freedom Watch's researchers are experienced in tracing down an original court pleading, report, or other document being discussed in the news, including using several document services typically employed. But we have not been able to find the actual report in the public domain. We waited a week to search a second time and see if the actual report would turn up in public sources, but it has not.

The <u>Saturday Telegraph</u>'s claim to have "exclusively" obtained the report appears to be more real than mere public relations. It appears that only the <u>Saturday Telegraph</u> (an edition of the Daily Telegraph) has a copy outside of the "Five Eyes" intelligence agencies themselves.

Therefore, we suggest that the ICC officially request a copy of the report – which has already been extensively discussed in public – from the United States, Canada, the United Kingdom, Australia, or New Zealand.

In the meantime we submit some of the news coverage that extensively discloses some of the content of the report, such as <u>The Saturday Telegraph</u> of Australia, May 2, 2020, but also published at Sharri, Markson, "Coronavirus NSW: Dossier lays out case against China bat virus program," May 4, 2020, accessible at:
