## Additional information pertaining to this service:

12/27/2022 1:40 pm: Arrived at 462 S. Beach Road and spoke to the security guard on duty. He told me that Tiger was not home. I asked if he could take down my information so I could arrange a meeting for service. The security guard went inside to get a piece of paper to take down my information. I gave him my name, business name and telephone number. He said that he would pass it along.

12/29/2022 11:45 am: Arrived at 462 S. Beach Road and the security guard did not come out of the home. His truck was backed into the space designated for security. I waited a few minutes and rang the call box and there was no answer.

12/29/2022 12:30 pm: Arrived at TGR Headquarters at 200 US-1, Jupiter, FL and saw that the office was closed for the holidays and would reopen on January 3 at 8:30 am.

12/30/2022 9:00 am: Arrived at 462 S. Beach Road, and the security guard didn't come out again. His truck was backed into the designated parking spot for security. I waited a few minutes before leaving and called the call box with no answer. I saw that the driveway had a few tire marks from the dew on the road.

1/2/2023 7:37 pm: Arrived at 462 S. Beach Road and spoke to a new security guard by the name of Kevin Sallette. He told me that Tiger was not home. I asked him when he would be back, and he said he wasn't sure. I asked if he was in town, and he said Tiger was out of the country. I asked him if anyone else was home and he told me no. I told him I would leave a copy of the subpoena with him, and he stated he wasn't going to take it. I left the subpoena on the call box and left.

1/3/2023 9:00 am: Arrived at TGR Headquarters, 200 US-1, Jupiter, FL and spoke to the receptionist. She informed me that Tiger was not in the office and hardly ever visits. She said he may come to the office once every 2 months or so. I asked her if she knew if he was in town and she said she had no idea and that she doesn't have access to his schedule.

1/5/2023 2:30 pm: As of today, I have not heard from Mr. Woods or anyone on his behalf to arrange service as requested. Based on my experience as a process server, Mr. Woods appears to be intentionally evading service.
